**Verification**

- The original application for medical cannabis business license, and any amendment thereto without extenuating circumstances, was due to AMCC on or before December 30, 2022.
- Beginning on December 31, 2022, any amendment to a previously filed application may only be made upon petition to the Commission showing in detail the changes being requested and the alleged extenuating circumstances that have prevented the applicant from including the information in the original application.
- An applicant may file only one amended application during the offering period.
- A complete Petition for Amendment Due to Extenuating Circumstances includes this Verification cover page and a separate Requested Amendment Form (Form O) detailing each requested amendment.
- The deadline to submit a Petition for Amendment Due to Extenuating Circumstances is March 3, 2023, at 4:00 p.m. CST. All submissions must be received, by the deadline, at [applications@amcc.alabama.gov](mailto:applications@amcc.alabama.gov).
- Upon receipt of a Petition for Amendment Due to Extenuating Circumstances, AMCC will invoice the applicant the required amendment fee of \$2,500.00.
- The deadline to file a proposed amended application corresponding to a timely filed Petition for Amendment Due to Extenuating Circumstances, and timely paid amendment fee invoice, is March 24, 2023, at 4:00 p.m. CST.
- An amended application requires a full refiling of all required parts of the original application (whether or not modified) and such amended application may not incorporate by reference or adopt any portion of the original filing. (Any application item or exhibit which contains no amendment will remain, as originally filed, in the application portal.)
- The applicant must submit “Original” and “Redacted” USBs of all refiled materials (whether or not modified), in accordance with Section 1.8 of the Application Guide.
- The applicant must submit a “Redline” USB showing a redline version of any changes made to the application and/or exhibits.
- The Commission, at its meeting on April 13, 2023, will vote to accept or reject timely and properly filed petitions and proposed amended applications.
- The applicant’s failure to timely and properly file any item required with an amended application will result in the Commission’s denial of the applicant’s petition and/or amended application.
