

Alabama Medical Cannabis Commission Meeting

Minutes

April 13, 2023

The Alabama Medical Cannabis Commission met on April 13, 2023, in the RSA Dexter Conference Room. The meeting was called to order by Chairman Steven Stokes at 11:00 A.M.

Mr. James Harwell led the Commission's invocation. The roll was taken with a quorum present. Commission members present for the meeting were Dr. Steven Stokes, Mr. Rex Vaughn, Dr. Sam Blakemore, Mr. Dwight Gamble, Dr. Angela Martin, Dr. Eric Jensen, Ms. Loree Skelton, Judge Charles Price, Ms. Taylor Hatchett, Mr. James Harwell, Dr. Jerzy P. Szaflarski, and Mr. Dion Robinson. No members were absent from the meeting.

Chairman Stokes presented the minutes from the March 9, 2023, Commission meeting. A motion to approve the minutes was made by Ms. Skelton, seconded by Mr. Vaughn, and received unanimous approval by the Commission.

Chairman Stokes stated that the Commission would move into executive session. He asked Mr. Justin Aday to explain the items which the Commission will address, and the legal authority to justify the executive session.

Mr. Aday explained that in the executive session the Commission would discuss the application evaluation process, the upcoming votes, and the matter of pending litigation and legal ramifications. He noted that these discussions meet the requirements for executive session under Section 36-25A-7(1) and Section 36-25A-7(3), Code of Alabama 1975.

A motion to recess for executive session was made by Mr. Vaughn, seconded by Ms. Skelton, and received unanimous approval by the Commission.

The Commission entered executive session at 11:04 A.M.

The Commission reconvened the public meeting at 1:40 P.M.

Chairman Stokes moved to discuss the five decision items before the Commission. He explained that the first decision item was to formally accept proposed deficiency corrections as noted in the Commissioner's meeting packet for decision items referenced as Decision Item #1 (attached hereto). A motion to accept deficiency corrections as submitted was made by Dr. Saliski, seconded by Judge Price, and received unanimous approval by the Commission.

Chairman Stokes then presented a decision item to formally grant or deny extraordinary time deficiency correction requests as provided by Decision Item #2 (attached hereto) in the Commission's meeting packet. A motion to grant extraordinary time requests was made by Dr. Blakemore, seconded by Ms. Skelton, and received unanimous approval by the Commission.

A third vote to formally deem applications corrected or not was then presented by Chairman Stokes. A motion to formally deem applications corrected, as outlined on Decision Item #3

(attached hereto), was made by Mr. Gamble, seconded by Ms. Hatchett, and received unanimous approval by the Commission.

Chairman Stokes presented the fourth decision item to formally grant or deny petitions to amend applications due to extenuating circumstances and to accept or not the proposed amendments. Mr. Vaughn made a motion to grant the petitions to amend and accept the proposed amendments as detailed on Decision Item #4 (attached hereto). The motion was seconded by Dr. Blakemore and received unanimous approval by the Commission.

The final decision before the Commission was to accept as final and deem submitted all properly filed and corrected applications as noted on Decision Item #5 (attached hereto). A motion was made by Ms. Skelton, seconded by Vaughn, and received unanimous approval by the Commission.

Chairman Stokes explained that the applications that the Commission has deemed submitted will move into the review, evaluation and scoring phase of the application process. He also noted that the Commission's vote to deem an application submitted does not in any way indicate that the applicant is eligible for a license.

Chairman Stokes then recognized Ms. Brittany Peters. Ms. Peters explained that the applications deemed submitted would become subject to public examination beginning April 14, 2023, and that the redacted copy of such applications would be made available on the Commission's website. She also noted that the Commission would accept public comments in favor or opposed to granting a license to a particular applicant until May 14, 2023.

Chairman Stokes and Dr. Saliski then recognized Mr. Mark Jackson (Executive Director of the Medical Association) and Mr. Matt Hart (Alabama Board of Medical Examiners) for an update on physician certification. Mr. Jackson explained that the physician certification course had been recorded and they anticipate releasing the course in the coming weeks. Mr. Hart noted that the Board of Medical Examiners was prepared to begin certifying physicians once the AMCC had awarded business licenses.

There being no further business, a motion to adjourn was made by Mr. Harwell, seconded by Dr. Jensen, and unanimously approved by the Commission. The meeting adjourned at 1:48 P.M.
