Penalties & Fines

Ala. Code § 20-2A-57(b)

"The commission may impose civil fines of up to five thousand dollars (\$5,000) against an individual and up to twenty-five thousand dollars (\$25,000) or an amount equal to the daily gross receipts, whichever is greater, against a licensee for each violation of this article, rules, or an order of the commission. Assessment of a civil fine under this subsection is not a bar to the investigation, arrest, charging, or prosecution of an individual for any other violation of this article and is not grounds to suppress evidence in any criminal prosecution that arises under this article or any other law of this state."
